

Terms & Conditions

MEMBERS DRAW 21/01/22 – 30/06/22

The 'Members Draw' promotion ("promotion") commences at 10am on Monday 21st January 2022 and concludes at the final prize draw on Thursday 30th June at approximately 8pm.

1. Introduction

- 1.1. These Terms and Conditions are binding once you receive an entry into the Members Draw, operated by PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC.
- 1.2. The Members Draw Rules apply to all PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC promotional draws. PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC. may amend them from time to time. If special Terms and Conditions apply to a particular draws, any change will be included in the particular Draw Rules.
- 1.3. Copies of Draw Rules are available on request from PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC. (Please e-mail reception@palmbeachsurfclub.com.au or ask at Reception).
- 1.4. By entering and participating in any draw, you understand and accept these Terms and Conditions. All entry instructions and any other specific details relating to the draw or the prizes form part of these Terms.

2. Eligibility

- 2.1. On the date of draws, you must be a financial member of the PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC.
- 2.2. Patrons who are suspended or excluded, including self-exclusion, from PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC Inc are not eligible to participate
- 2.3. Unfinancial members of PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC including those that have not renewed, board of directors, management, employees of PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC and related corporations including their advertising agencies are not eligible to enter the promotion or win.
- 2.4. If the entry of a suspended or excluded person is drawn from the entry barrel, the entry is deemed to be null and void and a re-draw will be conducted.
- 2.3 In order to participate in the Promotion, persons must be 18 years of age or over.
- 2.4 You must provide personal details as reasonably requested to do so by PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC. Refusal to comply will result in disqualification from the draw.
- 2.5 All decisions of PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC will be final and binding. No correspondence will be entered into.

3. ENTRY

- 3.1. Current 2021 - 2022 – 2023 - 2024 members of PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC who spend \$5.00 in any one transaction using their membership card at the Restaurant, Café or Bar OR turnover \$10.00 or more whilst playing a gaming machine, during the promotion period will receive one (1) virtual entry for EVERY \$10.00 to enter the Promotion.
- 3.2. The \$5.00 spend or more must be in one transaction at one register.
- 3.3. Transactions where rewards points are used as payment will not receive an automatic entry except where the transaction includes a remaining balance of cash or eftpos of \$5.00 or more.
- 3.4. One entry per \$10.00 transaction per session.
- 3.5. Prize draw entries will continue to be added to the entry pool throughout the entire promotion period including during draws.
- 3.6. Prize draw entries will remain be valid for the duration of the promotion period.
- 3.7. Should any selected entry be found to be invalid, or a selected entrant is found to be disqualified or ineligible to win, a re-draw/s will take place immediately at the draw location.
- 3.8. Entries to any re-draw will include all valid entries (excluding already selected entries) for the promotion. All normal entry requirements apply to the re-draw.

4. Minor Prize Draws

- 4.1. On Thursday 03/03/22 – 30/06/22, three members will be drawn from the virtual entry portal
- 4.2. The winner/s will be announced over the Club PA system. The winner will be announced up to three times at 6.30pm, 7pm and 7.30pm over a one (1) minute period. If the first person called does not present themselves as per the terms below, a second winner will be announced, if the second person called does not present themselves as per the terms below, a third winner will be announced. If the third winner does not present themselves as per the terms below, the jackpot will increase by \$100 to the following Thursday draw.
- 4.3. If a winner is present at any one of the Thursday night draws (excluding Thursday 30th June 2022), the amount will reset to \$1,000 and continue to accumulate as per above reference.
- 4.4. Each Saturday draw will follow the same format, excluding the final draw on Saturday 28th August (referred to in point 5).
- 4.5. To be eligible to win, the selected Member must present himself/herself to a representative from PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC at the main draw location within the draw period of his/her name being announced.

- 5.2. The winner/s will be announced over the Club PA system. The winner will be announced from 6.30pm, 7pm and 7.30pm up to three (3) times over a one (1) minute period.
- 5.3. If a winner is not found within the first 3 draws, further draws will occur every 1mins until a winner is found as this final jackpot draw must be claimed on this night.
- 5.4. To be eligible to win, the selected Member must present himself/herself to a representative from PALM BEACH (QLD) SLSC SUPPORTERS CLUB INC at the main draw location at reception within the draw period one (1) minutes of his/her name being announced.
