# **President Mary Farrell** presented the key highlights of the season including:

 Operating under the new Constitution; with a Board managing the business affairs and Operations Committee focused on the life saving activities.

- Thank you to our Supporters Club who have provided support and financial contribution
- Nippers sustainable and supported program with Josh taking on the role
- Youth development program came runners up in the recent SLSQ Gold Coast Youth Development 'Youth Club of the Year' award
- · Promoting and living our Club Values
- Community involvement: including helping clean up after the flood, Movember and McPherson Community Service awards
- Acknowledgement of:
  - David Collins, our outgoing Treasurer
  - Gary Fraser, in his tenure as Supporters Club President

President invited members of the Operations Committee to speak to the members:

- JAC Josh Sealey: new to lifesaving but has 17 years of organising school sports program. As the new JAC, Josh aimed to build trust of the members this season, with a focus on providing a joyful program with something for all kids.
- Club Captain: Greg Clark stepped into role midway through the season; Club has been inspected by SLSQ on four occasions during the season with excellent results; increasing number of new patrol members and training being offered through the season is improving the depth of the patrol teams.
- **CTO Donna Riley:** training team is a good position; strong numbers with younger members coming into the team. Just completed further IRB training to increase the depth of our IRB drivers and crewies.
- Surf Sports Officer Ben Cox: further developing program from last season into this season
  across all age groups; looking to bring a nippers coach next season and keep development
  going through all age groups. Introduction of Ky Hurst as Head Coach this season was well
  received.
- Youth Development: with Yasmina & Clayton unable to attend the meeting, Mary Farrell provided an update with monthly excursion to rock pools, rock climbing, movies' and Aqua Splash being successful outings keeping youth engaged. The Club came runners up Youth Club of the year on the Gold Coast.

#### **Treasurer's Report**

Treasurer David Collins stepped down from the role in March as he moved interstate. The Board welcomed Scott Lyall to the role who presented the financial report to the members. Scott joins the Board with great experience as a Chartered Accountant and Chief Operating Officer with Burleigh Brewing.

Scott provided a short presentation highlighting the key financial outcomes of the year:

- write off of assets as result of a comprehensive review of the asset register.
- improved cash balance by \$15K per year.
- income is generated from a number of sources, not solely relying on members fees.
- Club has plans for increased fundraising and optimising dorm fees.

Tracy Adams of Dickfos Dunn Adam (DDA), who completed the audit of the Clubs accounts, was acknowledged. The report provided valuable recommendations that the Board will review and implement.

The Treasurer notified the members of their current Public Liability Insurance. Our Insurance is provided through **XL Insurance Company SE (AXA)** with \$50M in General Liability and \$50M in Product Liability through to 7 October 2022.
