

## **Club Captain's Report**

Well, it's been another big year and we have plenty to celebrate. In my first full year as Club Captain, I am continually reminded about what it is that makes Palmy the place it is for all of us. We continue to grow and develop as a Club and live the values that have set us up to succeed now and into the future.

We respect and acknowledge our past, the people, the place and our property.

We are united, welcoming and friendly to our existing members and any newcomers that are willing to be part of Palmy, and who also have a purpose to build on what we have.

Through our leadership we set the standard for others to follow, and encourage involvement for all of us, to continue to stay united, in keeping Palmy what it has become.

These values have as always been demonstrated on many fronts, but for me, this year it has been as community members, we have lived what we have been taught, and or learned, from being part of Palmy and the greater Surf Life Saving community.

There have been great examples of this throughout the season and in some cases, not even on our own beach. Some of our younger members responsible for physically saving lives, and although there are probably many examples that we are not aware of, I would like to highlight a few including the efforts of Charlotte Sutch who was able to assist somebody back to the beach on an unpatrolled beach in Northern New South Wales.

There is another example of 15 year olds, Kai Agyik and Grace Pooley who again saved the life of a swimmer who had experienced a medical condition whilst in the surf at Tallebudgera. The gentleman was met by paramedics once the two youngsters and another member of the public assisted him back to the beach. Following a short hospital stay, the man declared "they saved my life".

Finally, another example is of a very humble member who does not want to be identified publicly. A member who set out on a regular jog around the Palmy area only to come across a man who had collapsed on a boardwalk near Currumbin Creek and who was being attended by a friend who unfortunately did not have any experience in first aid or lifesaving. For our member, it was second nature to administer CPR while other onlookers spoke with emergency services on the phone and talked the paramedics to his location. In our members' words in speaking with him about an hour after his experience he "remembered looking at the patient thinking that the colour and look of his face was as it had been described in the training, however he was not prepared for that [in conducting CPR compressions] he had crushed his chest". For this member - and the thing that struck me after what he had done - almost instinctively, he had come straight to the beach to seek comfort and to debrief with his fellow members.

These examples are no more important than any others in explaining the essence of what the movement is all about. By its own description, we are here to save lives. To develop our young people and equip all of our members with the skills and knowledge they need to do what is necessary to maintain that number one aim. As members of not only Palmy and Surf Life Saving but also the wider community as a whole, we strive to maintain this aim.

If we take nothing else from what we learn at Palmy, can it be that we continue to seek more opportunities to learn all aspects of surf lifesaving, whatever it may be.

If you are a nipper parent, please ask about what you can learn and be prepared to be on the beach with your child or children and for what we ultimately aim for them to be: Lifesavers. It is your opportunity to be involved as well, so take it and savour it when you can do it with your young adults.

- If you are Youth Development Officer engaging with or encouraging our youth to stay in the Club.



## **Education Report**

We extend our congratulations to all our members who achieved awards this season and commend their willingness to continue learning and gaining new skills for their personal and community benefit. Our returning and new members have successfully maintained the high level of safety that the public is accustomed to on our beach.



In a challenging season where administrative requirements only seemed to increase, our volunteer trainers stepped up to deliver a wide range of courses to upskill our patrols and Nipper parents.

### These included:

- Four Bronze Medallion courses with a total of 47 new lifesavers (some pictured above)
- Two Surf Rescue Certificate courses with 17 graduates
- 21 Inflatable Rescue Boat (IRB) crewies, including 11 from our youth development program
- Four new IRB drivers to bolster our patrols
- 67 members who completed First Aid
- 23 members who updated their Advanced Resuscitation skills (ART)
- Two members who obtained their Silver Medallion Aquatic Rescue through SLS NSW

Five Skills Maintenance sessions were held from August to December to ensure our lifesavers skills were in good shape. We highly encourage members to attend proficiency sessions earlier in the season to spread the load on our trainers and ensure that the last session held is manageable. A number of members missed the December 31st cut-off as they couldn't make the last session (which proved to be quite the challenging conditions!).

Mid-season, we congratulated our Chief Training Officer Donna Riley on her new Principal's post in Gunnedah, NSW. With Donna unable to deliver courses in person, Palm Beach stalwart Richard Andrews stepped in as lead trainer to ensure our members could still upskill. We extend our thanks to Richard and our other trainers Codey Trethewey, Matt Barber, Sam Morgan, Clayton Kimeklis and Zelda Jennings for their assistance.

We also want to thank Colin Harvey, Andrew Gault, Nick Perugino and Codey Trethewey for undertaking training to deliver Tractor and SSV operator courses. Another 11 more SSV and seven Tractor operators were trained up during the second half of our season. We also thank our IRB drivers for supporting our IRB courses, without whom we could not train our new award holders.

The increased workloads put on our training officers with administrative paperwork is noticed and their time highly appreciated. It also doesn't go unnoticed the amount of training that is required of members and the time and sometimes complexity involved in completing training. SLSQ are aware of the challenges and have advised Club Presidents they will be working on some improvements to education processes for trainers and members over the coming months. We look forward to working through these with them.

Finally, we are always seeking more trainers to alleviate the workload on our current trainers and to take over the mantle in the future. If you are a skilled presenter or teacher or know any educators who would might like to train volunteer lifesavers, please get in touch.



## **Youth Development Report**

After coming off a high from the end of last season where we took out Runners up for the 2021-2022 Gold Coast Youth Development Club of the Year, we set our sights on building on what we had already established and welcomed the opportunity to grow and develop our Youth Development Program further.

This season, we saw many of our youth commit to the protection and safety of our community members by attending the Surf Rescue Certificate (SRC) camp and others obtaining their Bronze Medallion. Congratulations to all our youth who obtained these awards and skills. Special mention to our Junior Club Captains Rose Cooper and Villie Leighton-Wright and Vice Captains Tully Jenkins and Hayden Sutch who were voted in during the U14's SRC Camp. You are all fine leaders who demonstrate the values of Palm Beach SLSC - Respect, Unity, Inclusive and Involvement

December quickly arrived with Santa and his Elf returning to our beloved Palmy to distribute lollies to our Nippers. Once again our youth stepped up and leant a helping hand with the younger Nippers, leading the way to assist with age group photos and ensuring our Nippers could get their photos with Santa and his Elf too.

## **Grants Report**

We are pleased to report that we secured \$63,070 in grant funding this season through our submission of grant applications at local, state and federal level as well as within the private sector.

Grants assist our Club in funding key projects and equipment purchases that align with our Club's needs whilst meeting the criteria of each grant program. While we were unsuccessful in applications to upgrade our gym equipment and add solar panels to our building, we will continue to source avenues to make these improvements.

Grant success last season enabled our Club to upgrade our training room cabinetry and technology, procure a new IRB trailer, 4 rescue boards, 10 rescue tubes, 2 swim fins, a radio charging station, upgrade our CPR mannikins and buy a new marquee for Nippers. Funds have also been spent in supporting our volunteers to attend training courses, and tickets to the SLSQ conference – a key information sharing tool for our volunteer leaders.

With the success of this season's grant applications, projects and equipment that we will now be able to acquire over the off-season include:

- a new Patrol Arena/Trailer
- a replacement SSV
- renovations to mitigate mould damage in our former Club office (providing further storage for our training equipment)
- a fully equipped Search and Rescue Kit
- two marquees for Nippers (plus an additional marquee for Patrol with funds saved)
- a replacement whiteboard and lectern for our trainers
- an IRB motor

We will continue to seek out grant opportunities to support our Club's growth and development. However, if any of our members hear of a grant we could apply for, please share details with our Club office.

Gary was presented with his Life Membership pin on March 4 2023 in front of our 2022/23 season Palm Beach Nippers and his award celebrated afterwards with fellow Life Members and members in our Supporters Club.





### **Mr Leo Anisimoff**

### 14 October 1927 - 30 June 2022

In June 2022 we lost our oldest surviving member, Leo Anisimoff, whose long standing record of service to Palm Beach Qld and to Point Danger Branch as a representative of our Club (and including service to his Country) probably should have earned him Life Membership some time ago. Unfortunately, at the time, Life Members under the Constitution had to be nominated through other members and this never occurred. In recent years an attempt to recognise his efforts was made by bestowing an Honorary Life Governorship on him.

Leo was meticulous in whatever he did and kept scrapbooks, photo albums, news items and other memorabilia related to his service. Together with his loving wife Anna, Leo also developed a Tugun supermarket and post office, making some lifelong friends along the way – themselves legends in the community, like the Neumanns, Sawtells, Georgie Stone, Comadiras, Frizzells and too many others to mention.

In one of Anna's quotes: "Leo and me: we were one...body and soul".

The Anisimoff's not only assisted Palm Beach SLSC but also the general community including Currumbin Vikings SLSC.

Leo's service record includes: After the War in 1945 he joined Palm Beach as an Active Senior. Leo was a First stroke in the legendary boat crew of Blondie Gray 46-49 culminating in Palm Beach's first ever Queensland Senior Boat Title. Leo gained his Instructor's Certificate in 1950 was number one Member of the Branch Board of Examiners. In 1952-53, he undertook Registrar and Radio Officer duties as well as Branch Delegate. Leo was responsible for retraining all members in the "new Holger Nielsen" resuscitation technique replacing Sylvester Broche. In 1954 Leo took on several roles including Club radio officer, Branch delegate, Assistant Secretary and official examiner, as well as Point Danger Secretary. As an Active Reserve, Leo officiated in many carnivals including

Aussies in 1955. Leo was responsible for the effective training of our members for their Bronze Medallions as well as members from other Clubs through all the years from 1950 to 1960, and worked as a carnival judge at all levels - mainly in boat arenas.

Leo and Anna always enjoyed the company of good friends and especially the "May Day Dinner" now the Annual Dinner.

A great couple and a sad loss of one great citizen and our esteemed member.

Leo is survived by his wife Anna, with whom he recently celebrated 65 years marriage, and was 95 years young.





### **Mr Gordon Shears**

27 December 1951 - 15 August 2022

Gordon Shears was a long lasting "Eveready Battery" of the Club. Gordon was involved in practically every side of the Club from administration to patrol and competing. Having joined Palm Beach in 1979 from a Sydney based career in surf lifesaving, Gordon powered on until his central controller failed and delivered the gradual stages of Dementia to a relatively young, fit and aware man. Throughout his journey, Gordon's family (wife Jenny , daughter Naomi and her husband Kenny), along with lifelong friend and paddling co-partner "Bucky" Landers and past members like Gary Thomas, showed Gordon unwavering support which aided in his transition.



The difficult thing in summarising Gordon's membership is trying to include all

his active roles. For 40 years he served on the beach, finishing his patrols with the Warwick Boys. He held almost every position in the Club including President (3 years), Supporters Club Committee member, Club Captain and Vice Captain, Gear Steward, board and ski captain, first aid officer, IRB captain, radio officer, treasurer and secretary. Such a long history of always being there when needed and a history of dedicated service.

Gordon's knowledge of the printing industry saw him head up the annual calendar fundraiser for 20 years, design the latest Club logo, reprint some of the historical memorabilia of the Club and edit and print the 75th Anniversary book. Gordon also collated and produced the Annual Report for 15 years. Gordon willingly volunteered in other Club fundraising initiatives and promotions and one of his many initiatives also introduced Grant, a member of the legendary Baldock SLS family, to train an R and R team to gain what is the only Aussie medal the Club has ever won in this event. Gordon's daughter Naomi was part of the winning team.

Gordon's weapons in competition were his beloved ski and paddle and a resolute drive, winning many well credentialed events over 35 years, and leading to he and "Bucky" Landers earning a gold medal win in Master's at Australian Titles. A little known fact is that he also rowed for the Club in 1981 at the World Life Saving Titles in Kuta. Gordon's love of Bali and long association with Made Suparka— president of Life Saving Indonesia at the time - along with a liking for a *Bintang* in "Wayans Bar", will see the Shears' family spread some of Gordon's ashes in his second country of welcome.

How do you summarise the life of a great contributor to our community and society.

### Mr Barry 'Basil' Jukes

18 January 1937 - 10 September 2022

After a battle with Dementia in his latter years, Basil passed away in September of 2022 at the age of 85. His friends and family were saddened by the decline of a man with such a sharp mind and unbelievable memory.

Not many can boast the degree of involvement he had in his Club. Since joining in the 1950's, except for transfers with work and other business matters, Basil remained an active and involved member throughout his continued service since joining. All this through a varied and interesting career and raising four children. Basil also enjoyed fishing and shooting, once demonstrating his skills by putting a bullet hole through a matchbox thrown into the air.

Basil's history dates back to firing up his beloved Ford Zephyr to commute from Cunnamulla to the Club; a trip he probably still holds the land speed record for. Basil was Club Captain by 1961 and his love of surfboat sports had him sweeping 2 crews. As a very capable sweep, he and his crew of seniors were selected in 1964 to represent Queensland in the Australian Titles. The same year, Basil married Robin and they began their family planning– four kids, then grandkids. Basil found essential time for everything.

Around about this time Basil was transferred to Rockhampton where he gained reciprocal membership and swept the boat crew at Yeppoon SLSC.

In 1971 he was awarded Life Membership of Palm Beach Qld SLSC and continued to deliver great results in the boats as well as tutoring younger sweeps who helped handle the several crews rowing in that era. He was also Secretary in 1972 and 73, Vice President in 1975.

Clubs had to source their own funds and Basil drove across the city weekly to Springwood and other venues to manage and conduct Bingo sessions, as well as being skilled at finding sponsors and contributors. When House to House collections were a means of gaining funds, the collections were often run through his home. Short of collectors one year, his daughter Kerry, a teacher, organised the assistance of school students.

At the design planning stage of the "new" Clubhouse, Basil owned a quarry business and in 1997 generously contributed to the buge rock walls required to meet specifications a percendity.

contributed to the huge rock walls required to meet specifications—personally supervising and managing its construction. His interest also had him seek election on the Supporters Club Committee up to 1999, helping that Committee to steer the Club through some troubled times and reducing the burden of a large loan very efficiently. Basil also played a prominent role in organising and promoting the Club's 75th Anniversary activities.

Basil's love of boats never waned and he helped initiate "The Fossil Project" as well as gaining donations for new boats, gear and trailers along the way. He continued to support his Club at Committee meetings up until he was unable to.

A great man, a great member and a lifelong supporter. He'll be somewhere telling them about his surf skills and the size of waves he and his crews regularly conquered in the days when a Carnival was rarely ever cancelled due to big seas.

### Mr Ian 'Joey' Cowper

Married and father of two children, Joanne and Paul, Joey also shared a special bond with his brother Bruce and nephew Daniel; also a long term member.



Joey joined Palm Beach in 1964 and fitted in well, enjoying the mateship and support of fellow members throughout his long association with the Club.

In 1965 he was Secretary, Vice Captain in seasons 1992-1996, Treasurer in 2001-2003, as well as First Aid Officer and trainer in interim years. After a period living in New Guinea and time spent in Tasmania, Joey acquired property in Palm Beach and spent a lot of his life locally, eventually moving to Tweed Heads. On the Coast, he gained his pilot's licence. He looked so spivvy going to work in his uniform as a pilot instructor at Coolangatta Airport. Joey's spare time was spent surfing and he adopted the nickname Joey Cabell (a noted professional) for some of his pursuits. Joey also had an interest in cars and bikes and for many years owned vintage MG sports cars. In his later years, his great friend "Zorro" (Ian Sarow) talked Joey into joining the Men's Shed group. Over the years his growing belief in Christianity saw him playing the drums in church services and the Church also provided him with a set of beliefs which always seemed to keep him cheery in all situations.

He never forgot his Club and those who knew him will never forget the times we had and a great Club Man.







### Notes to the Financial Statements

For the Year Ended 30 April 2023

The financial statements cover Palm Beach QLD Surf Life Saving Club Inc as an individual entity. Palm Beach QLD Surf Life Saving Club Inc is a not-for-profit Association incorporated in Queensland under the Associations Incorporations Act 1981 (QLD) (as amended by the Associations Incorporation and Other Legislation Amendment Act (QLD) 2020), and registered under Division 60 of the Australian Charities and Not-for-profits Commission Act 2012.

The functional and presentation currency of Palm Beach QLD Surf Life Saving Club Inc is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

#### 1 Basis of Preparation

The Association is not a reporting entity since there are unlikely to exist users of the financial statements who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the Act.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 *Presentation of Financial Statements*, AASB 107 *Statement of Cash Flows*, AASB 108 *Accounting Policies*, *Changes in Accounting Estimates and Errors* and AASB 1054 *Australian Additional Disclosures*.

#### New and amended Australian Accounting Standards that are effective for the current year

At the date of authorisation of these financial statements, the Association has not applied the following new and revised accounting standards that have been issued but are not yet effective.

- AASB 2020-1 Amendments to Australian Accounting Standards -Disclosure of accounting policies;
- AASB 2020-1 Amendments to Australian Accounting Standards Classification of Liabilities as Current or Non-Current: and
- AASB 2021-2 Disclosure of Accounting Policies, Changes in Accounting Estimates and Errors—Definition of Accounting Estimates.

The committee do not expect that the adoption of the Standards listed above will have a material impact on the financial statements of the association and in the main will only impact additional disclosures in the accounting policy notes in future periods

#### 2 Summary of Significant Accounting Policies

#### (a) Income Tax

No provision for income tax has been raised, as the club is exempt from income tax under Div 50 of the Income Tax Assessment Act 1997.

#### (b) Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payable are stated inclusive of GST.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

  - (c) Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment.

Land and buildings

Buildings are measured using the cost model.

Freehold land is measured using the revaluation model.

#### Plant and equipment

Plant and equipment are measured using the cost model.

#### Depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the assets useful life to the Association, commencing when the asset is ready for use.

Leased assets and leasehold improvements are amortised over the shorter of either the unexpired period of the lease or their estimated useful life.

Freehold land is not depreciated. The depreciation rates used for each class of depreciable asset are shown below:

Fixed asset class	Depreciation rate
Surf club equipment	2.5%-33.33%
Buildings and improvements	2.5%-15%
Plant and Equipment	10%-20%
Office equipment	25%-33%
Furniture, Fixtures and Fittings	10%-20%
Motor Vehicles	15%

At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

#### (d) Leases

At the lease commencement, the Association recognises a right-of-use asset and associated lease liability for the lease term. The lease term includes extension periods where the Association believes it is reasonably certain that the option will be exercised.

The right-of-use asset is measured using the cost model where cost on initial recognition comprises of the lease liability, initial direct costs, prepaid lease payments, estimated cost of removal and restoration less any lease incentives received.

The right-of-use asset is depreciated over the lease term on a straight line basis and assessed for impairment

#### (d) Leases

in accordance with the impairment of assets accounting policy.

The lease liability is initially measured at the present value of the remaining lease payments at the commencement of the lease. The discount rate is the rate implicit in the lease, however where this cannot be readily determined then the Association's incremental borrowing rate is used.

Subsequent to initial recognition, the lease liability is measured at amortised cost using the effective interest rate method. The lease liability is remeasured whether there is a lease modification, change in estimate of the lease term or index upon which the lease payments are based (e.g. CPI) or a change in the Association's assessment of lease term.

Where the lease liability is remeasured, the right-of-use asset is adjusted to reflect the remeasurement or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

Exceptions to lease accounting

The Association has elected to apply the exceptions to lease accounting for both short-term leases (i.e. leases with a term of less than or equal to 12 months) and leases of low-value assets. The Association recognises the payments associated with these leases as an expense on a straight-line basis over the lease term.

#### 3 Critical Accounting Estimates and Judgments

The Board make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

#### Key estimates - impairment of property, plant and equipment

The Association assesses impairment at the end of each reporting period by evaluating conditions specific to the Association that may be indicative of impairment triggers. Recoverable amounts of relevant assets are reassessed using value-in-use calculations which incorporate various key assumptions.

#### Key estimates - useful life of fixed assets

The Association reviews its estimate of the useful life of depreciable assets at each reporting date, based on the expected utility of the assets.

#### Key estimates - provision

As described in the accounting policies, provisions are measured at management's best estimate of the expenditure required to settle the obligation at the end of the reporting period. These estimates are made taking into account a range of possible outcomes and will vary as further information is obtained.

The Association reviews its estimates the net realisable values of inventories, taking into account the most reliable evidence available at each reporting date.

The financial statements cover Palm Beach QLD Surf Lifesaving Club Supporters Club Inc as an individual entity. Palm Beach QLD Surf Lifesaving Club Supporters Club Inc is a not-for-profit Association incorporated in New South Wales under the Associations Incorporations Act 1981 (QLD) (as amended by the Associations Incorporation and Other Legislation Amendment Act (QLD) 2020).

The functional and presentation currency of Palm Beach QLD Surf Lifesaving Club Supporters Club Inc is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

#### 1 Basis of Preparation

In the opinion of the Committee of Management, the Association is not a reporting entity since there are unlikely to exist users of the financial statements who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the Act.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 *Presentation of Financial Statements*, AASB 107 *Statement of Cash Flows*, AASB 108 *Accounting Policies*, *Changes in Accounting Estimates and Errors* and AASB 1054 *Australian Additional Disclosures*.

#### New and amended Australian Accounting Standards that are effective for the current year

At the date of authorisation of these financial statements, the Association has not applied the following new and revised accounting standards that have been issued but are not yet effective.

- AASB 2020-1 Amendments to Australian Accounting Standards -Disclosure of accounting policies;
- AASB 2020-1 Amendments to Australian Accounting Standards Classification of Liabilities as Current or Non-Current; and
- AASB 2021-2 Disclosure of Accounting Policies, Changes in Accounting Estimates and Errors—Definition of Accounting Estimates.

The committee do not expect that the adoption of the Standards listed above will have a material impact on the financial statements of the association and in the main will only impact additional disclosures in the accounting policy notes in future periods

#### 2 Summary of Significant Accounting Policies

#### (a) Income Tax

The Income Tax Assessment Act 1997 provides that under the concept of mutuality clubs are only liable for income tax on income derived from non-members and from outside entities.

The income tax expense (revenue) for the year comprises current income tax expense (income) and deferred tax expense (income).

Current income tax expense charged to the profit or loss is the tax payable on taxable income calculated using applicable income tax rates enacted, or substantially enacted, as at the end of the reporting year. Current tax liabilities (assets) are therefore measured at the amounts expected to be paid to (recovered from) the relevant taxation authority.

#### (b) Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payable are stated inclusive of GST.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

#### (c) Property, plant and equipment

#### Plant and equipment

Plant and equipment are measured using the cost model.

#### Depreciation

Property, plant and equipment is depreciated on a straight-line basis over the assets useful life to the Association, commencing when the asset is ready for use.

The depreciation rates used for each class of depreciable asset are shown below:

At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

#### (d) Operating leases

The Association lease land, building and improvements for period up to 10 years from the Surf Club. Lease contracts may contain both lease and non-lease components. The Association allocates the consideration in the contract to the lease and non-lease components based on their relative stand-alone price. Lease terms are negotiated on an individual basis and contain a wide range of different terms and conditions. The lease agreements do not impose any covenants other than the security interest in the leased asset that are held by the lessor. Leased assets may not be used as security for borrowings purposes.

The Association has elected IT equipment and other plant and equipment meeting the criteria of low-value assets are recognised as such. Leases of low-value assets and payments relating to short-term leases (leases with a less term of 12 months or less) are recognised on a straight-line basis as an expense.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement lease liability;

- restoration costs.

Right-of-use are depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. If the Association is reasonably certain to exercise a purchase option, the right-of-use asset is depreciated over the underlying asset's useful life.

Liability arising from a lease are initially measured on a present value basis. Lease liability include the net present value of the following lease payments:

-fixed payments (including in-substance fixed payments), less any lease incentives receivable;

-variable lease payment that are based on an index or a rate, initially measured using the index or rate as at the commencement date;

-amounts expected to be payable the Association under residual value guarantees;

the exercise price of a purchase option if the Association is reasonably certain to exercise that option; and,

-payments of penalties for terminating the lease term reflects the Associations exercising that option.

#### 3 Critical Accounting Estimates and Judgments

The Committee make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

#### Key estimates - impairment of property, plant and equipment

The Association assesses impairment at the end of each reporting period by evaluating conditions specific to the Association that may be indicative of impairment triggers. Recoverable amounts of relevant assets are reassessed using value-in-use calculations which incorporate various key assumptions.

#### Key estimates - impairment of intangible assets

The Association monitor the fair value of website for indication of impairment on entitlements held at cost.

#### Key estimates - useful life of fixed assets

The Association reviews its estimate of the useful life of depreciable assets at each reporting date, based on the expected utility of the assets.

#### Key estimates - provisions

As described in the accounting policies, provisions are measured at management's best estimate of the expenditure required to settle the obligation at the end of the reporting period. These estimates are made taking into account a range of possible outcomes and will vary as further information is obtained.

#### Key estimates - provisions for gaming jackpots

The Association reviews its estimates and judgments for the methodology for the provision for gaming jackpots each reporting date. The Association takes up 100% of the jackpot liability.

#### Key estimates - receivables
